#### **Board of Director Announcement:**

The Annual Meeting will be held in April at the Hamilton County Senior High School Gym in McLeansboro. This year Broughton 647, Dahlgren 736, and the Dale 773 exchanges will be up for Director Elections.

If you are not the nominee selected by the committee and would like your name printed in the annual meeting booklet, you will need to file your petition by February 15th due to the printing lead time requirements.
