

### **Affordable Connectivity Program**

The Affordable Connectivity Program (ACP) is a Federal Communications Commission (FCC) program that replaced the Emergency Broadband Benefit Program (EBB Program) to help low-income households pay for internet service and connected devices.

If your household is eligible, you can receive:

Up to a \$30/month discount on your internet service.

Up to a \$75/month discount if your household is on qualifying Tribal lands.

A one-time discount of up to \$100 for a laptop, tablet, or desktop computer (with a co-payment of more than \$10 but less than \$50)

Step 1: Check if you qualify. Visit <a href="www.fcc.gov/acp">www.fcc.gov/acp</a> for qualifications.

Step 2: Apply for the Affordable Connectivity Program. Apply online at AffordableConnectivity.gov.

Step 3: Please contact our office at 618-736-2211 to let us know you have applied and qualify. Once confirmed, we will apply the benefit to your bill monthly.

### **Board of Director Announcement:**

At this time, we are already underway planning for our 2023 Annual Meeting. The meeting will be held on April 14 at the Hamilton County Senior High School Gym in McLeansboro. This year the Broughton (647), Dahlgren (736), and Dale (773) exchanges will be up for Director Elections.

According to the HCTC By-laws, the nominating committees for the Broughton (647), Dahlgren (736), and Dale (773) exchanges have been selected by the Board of Directors. It is the responsibility of the nominating committee to select at least one certified nominee for Director to represent their exchange for a three year term.

The nominating committee for the 647 exchange nominated Steven Douglass to serve another three year term on the HCTC Board. The nominating committee for the 736 exchange nominated Lemuel Gage to serve another three year term on the HCTC Board. The nominating committee for the 773 exchange nominated Robert Abbott to serve another three year term on the HCTC Board. The Co-op thanks the nominating committees for their time and service, making certain that we continue to have representation from these exchanges for the next three years. Although the nominees as candidates are selected by these committees, the by-laws also allow for any other certified member of these exchanges the same right in running and serving a three year term as Director for their exchange. If you are interested, you can pick up a petition (required to be signed by 10% or 15 certified members, whichever is less, of your exchange) at the co-op from the General Manager, along with the specific details and requirements of serving as a Director.

You will have until March 15th to file your certified petition with the Co-op for your name to be placed on the ballot at the annual meeting. If you are not the nominee selected by the committee and would like your name printed in the annual meeting booklet, you will need to file your petition by February 15th due to the printing lead time requirements.

We look forward to seeing you at the Annual Meeting in 2023.
