The Year Ahead

Hope you all had a Merry Christmas!!!

As we say goodbye to 2022, I want to take a moment to thank each of you for your service with us.

As our landlines continue to decline and approximately 60% of our members still use DSL services over copper for their internet connection, we know that this is not good enough. Many of you ask, "when are we going to get fiber?" This has always been a difficult question to answer, because it takes a lot of money to construct a fiber network and it doesn't just happen overnight.

However, we have been tenacious in our search for solving this problem and we are happy to announce that persistence has finally paid off. Just recently, we were provided notice that our application submitted for Reconnect 3 was approved. This is a loan and grant combination designed to provide fiber throughout all areas of our Co-op not currently served by fiber, as well as, some portions of Hamilton County outside of our Co-op exchange boundaries. Reconnect 3 was the first funding available through USDA with the minimum 100/20 threshold, finally enabling us with a solution to upgrade the rest of our Co-op. The amount of this loan/grant is \$24,826,724, half loan and half grant. We are very excited about the opportunity to upgrade our entire network with fiber capabilities and bringing you this service. We have learned from the past couple of awards, that the paperwork side of the process does take awhile, but we hope to get started on construction by the end of 2023. We will share more news as it becomes available.

Our Annual Meeting will be held in April 2023. This year we will have three exchanges up for reelection. These exchanges are Broughton (647), Dahlgren (736), and Dale (773). If you live in one of these exchanges and are interested in serving as a director, please contact me for more information.

If you are still a telephone customer, you should have received our 2022 telephone directory. This year's directory is very similar to last year's book and it will be our last booklet printing going forward. If you need a copy of our directory, you are welcome to stop by the Co-op anytime to pick one up. This will also be available on our website.

We pray that those we serve are blessed in health, finance, and they truly experience a Happy New Year!!!

If you are not the nominee selected by the committee and would like your name printed in the annual meeting booklet, you will need to file your petition by February 15th due to the printing lead time requirements.
