

Battery Backup Power for Fiber Customers Notice

This is an annual notice to our customers that Hamilton County Telephone Co-op fiber services require backup battery power to continue functioning during a power outage. To avoid a disruption of voice (telephone) services during an outage - and to maintain the ability to call 911 emergency services, HCTC provides a backup battery system during the installation of all telephone services on our fiber network.

This battery backup allows you to continue to use your telephone services for up to eight hours during a power outage. Without this battery backup or other alternate power source like a generator, fiber landline customers would be unable to make phone calls, including 911 calls, during a power outage. Our battery backup does not provide power to any other services except telephone services. It does not power cordless telephones. Home security systems, medical monitoring devices, electronic phones, or other equipment will not run on our backup battery.

This battery backup is provided to you at no charge during your installation. It will last up to eight hours, and will recharge automatically once power has been restored. HCTC will replace the battery backup at no cost if/when needed. If you have any questions, please call our office at 618-736-2211.

This battery backup is only necessary for customers on fiber. Landline customers still connected over our copper plant do not need this battery backup for their phone service to work during a power outage.

Call before you dig

It's a free service



As Spring time rapidly approaches, you may be planning to do some digging in your landscaping, yard, or around your property. Please remember that it is now the law in Illinois to call J.U.L.I.E. a minimum of two days before you dig. Here is a list of information you will need to provide:

- Your name, address, and a phone number at which you can be reached. An email, phone number, and a fax number, if available.
- The location where the excavation will take place, including county, city, or unincorporated township, section and quarter section numbers if available, address, cross street (within 1/4 mile), subdivision name, etc.
- State the date and time of planned excavation.
- Type and extent of excavation involved.

- Whether the dig area has been outlined with white paint, flags, or stakes.
